# 13. Session: Final Discussion

# The Anthropology of Citizenship in Post-Totalitarian States

Due to anthropology's classic obsession with stateless and/or "primitive" societies, the state was only recently discovered as an object of anthological thought. As a crucial criterion for state belonging and social entitlements as well as of exclusion and political control, citizenship is of increasing significance for the anthropology of the state. Transnational movements for universal human rights, "travelling" models of law and justice, and the globalization of economy and politics challenge the viability of citizenship in the contemporary world. Yet, citizenship is both an aim and a subversive practice in recent social movements all over the world.

In this course, we will discuss classic positions on citizenship from the social sciences (e.g. Weber, Marschall) as well as follow recent debates about multiculturalism and group rights (e.g. Kymlicka), migration and the nation state (e.g. Brubaker), and the ideology of civil society (e.g. Chatterjee, Hann, Walzer). A particular focus will be put on citizenship in post-totalitarian societies, be they post-socialist, post-colonial, or post-dictatorial. In comparing literature on citizenship in post-totalitarian societies, structural similarities of authoritarian rule as well as regional, cultural, and social particularities should become apparent.
